

**PERSONAL RELEASE (MINOR)**

Ladies and Gentlemen:

I understand and acknowledge that I am signing this Release and agreeing to the terms of this Release as full and complete consideration for University Camps, Inc. (dba UCLA UniCamp) (“UniCamp”) agreeing to consider including me as a camper at UniCamp’s camp in Barton Flats near Big Bear, California (“Campsite”). I also acknowledge that UniCamp is relying on the terms of this Release in considering the Minor as a camper and therefore, when signed, this Release shall be irrevocable and binding on me and the “Releasing Parties” (as defined below).

In consideration of the foregoing, and without any further consideration due to me or any other person or entity from UniCamp or any third party, I hereby acknowledge and agree as follows:

1. Application for Campership. I understand that if I am selected to participate in Camp, I agree to abide by all Camp rules and eligibility requirements. I understand that UniCamp may choose, in its sole discretion, whether or not to include me in the Camp and whether or not to continue my participation in the Camp.

2. Assumption of Risk. I understand and acknowledge that camping and other activities related to my participation in the Camp may be dangerous and could result in personal injury, death and/or property damage. **By signing this Release, I expressly assume all risks and dangers associated with and inherent in the activities and events related to my participation as a camper at UniCamp** (individually and collectively, the “Events”). Without limiting the generality of the foregoing, I understand and acknowledge that there may be risks and dangers that are undefined and presently unknown related to the Events, and that there may be risks and dangers that may result from the negligence of UniCamp or its employees and agents, such as (without limitation) risks and dangers related to providing instruction or guidance, as well as the selection, use, operation, design or maintenance of premises, facilities, locations and/or equipment related to the Events. **I expressly assume all such risks and dangers, whether presently known or unknown, on behalf of myself and the Releasing Parties.**

3. Waiver and Release. **On behalf of myself and my parents, legal guardians, heirs, personal representatives and next of kin (individually and collectively, the “Releasing Parties”), I hereby release, waive, discharge, and agree not to sue the “Released Parties” (as defined below) with respect to any and all claims, demands or causes of action that I or any of the Releasing Parties may have in connection with the Events and/or any use of the Materials (as defined below) whatsoever, whether in connection with the Program or otherwise.**

The foregoing release and the indemnity set forth in Paragraph 4 below shall include, without limitation, any and all claims of any kind or nature, whether at law or in equity, whether now known or unknown, suspected or unsuspected, for any and all present or future loss or damage, and all claims, liens, demands, causes of action, debts, liabilities, expenses (including court costs and attorneys’ fees), suits or judgments (collectively, “Liability”) on account of any personal injury, injury to personal property, or death arising out of or related to the Events and/or to my presence in or upon the premises, facilities and locations where the Events are or will be taking place (collectively, the “Location”). This includes, without limitation, Liability from any cause whatsoever, whether caused by the negligence of the Released Parties or otherwise.

On behalf of the Releasing Parties, I also hereby release, waive, discharge, and agree not to sue the Released Parties with respect to any Liability in any manner connected with the use and exercise of the rights granted to UniCamp under this Release, including, without limitation, the use or reuse of my appearance, name, voice, likeness and/or biographical information. The foregoing shall include, without limitation, any Liability related to claims based upon harm to my reputation, disparagement, invasion of privacy and/or rights of publicity.

The “Released Parties” shall mean UniCamp; UniCamp’s successors, licensees and assigns; any sponsors and advertisers; any other contestants, applicants or participants in the Events; and each of their affiliated parents, affiliates, shareholders, officers, directors, managing agents, employees, independent contractors, members, agents, representatives, attorneys, investors, affiliated organizations and entities; and any other persons or entities assisting or participating in the activities of any of the foregoing.

4. Indemnity. On behalf of myself and the Releasing Parties, I hereby agree to indemnify and hold the Released Parties harmless from any Liability whatsoever (including, without limitation, court costs and attorneys' fees) arising out of or related to this Release and/or my presence in or upon the Location and/or my participation in any way in the Events, including, without limitation, any statement, action or failure to act by me during or in connection with my participation in the Events, and any negligence or criminal conduct by me.

5. Grant of Rights. I hereby grant to UniCamp the irrevocable right (but not the obligation) to film, tape, photograph, and/or record, as well as the right to exhibit, edit and otherwise use my name, likeness, voice, conversation, sounds, appearances, and biographical data (collectively, my "Appearance") in any manner in UniCamp's sole election and sole discretion. I agree that UniCamp and its successors, licensees and assigns are the sole owner of all the results and proceeds of such film, tape, photography and/or recording and my Appearance thereon (collectively, the "Materials"), with the irrevocable right, forever and throughout the universe, to use the Materials and any portion thereof in any and all media, whether now known or hereafter devise.

6. Disqualification. I understand that any of the following may result in my disqualification from Camp: (a) my failure to follow any rules of Camp; (b) my failure to meet any requirements of Camp; (c) any breach of this Release by me or any of the Releasing Parties, or (d) my disaffirmation of this Release in whole or in part.

7. Warranties. I represent and warrant to UniCamp that (a) I am under the age of 18 and I have the permission of my parent or legal guardian to participate in the Program, as reflected by their concurrent signature of a separate Release related to Camp and (b) I have the full, complete and unrestricted right and authority to enter into this Release, to assume all risks and dangers associated with the Events, to waive and release all matters stated herein, to indemnify the Released Parties and to grant all rights granted hereunder. I further represent and warrant that I am of sound mind and intend to be bound by this Release.

8. Jurisdiction. I understand and agree that this Release shall be governed by the laws of the State of California applicable to agreements entered into and wholly performed therein. I hereby acknowledge that the State and Federal Courts located in the County of Los Angeles, California shall have exclusive jurisdiction over any disputes related to this Release or any matters pertaining to the Program and/or the Events, and I hereby expressly submit to such jurisdiction and waive any objections related thereto.

9. Entire Agreement; Severability. I understand and acknowledge that this Release represents the entire agreement and understanding between myself and UniCamp as to the matters set forth herein, and I expressly acknowledge that I am not relying on any verbal statements or inducements in signing this Release. The provisions of this Release may not be waived, altered or amended except by a written instrument signed by a duly authorized representative of both parties hereto. If one or more provisions of this Release are held to be illegal or unenforceable under applicable law, such illegal or unenforceable portion(s) shall be limited or excluded from this Release to the minimum extent required and the remaining portions of this Release shall be interpreted as if such portion(s) were so limited or excluded and shall be enforceable in accordance with its terms.

10. Free and Voluntary Signature and Release. **I expressly acknowledge that I have read this Release, I fully understand its terms, and I understand that this is an important legal document. I also understand and acknowledge that by signing this Release, I am giving up substantial legal rights, including rights on behalf of the Released Parties.**

**I am signing this Release freely and voluntarily without any inducement, assurance or guarantee being made to me or any of the Releasing Parties. I intend my signature to be a complete and unconditional release of liability to the greatest extent allowed by law.**

**I have been given ample opportunity to read this Release and to have it reviewed by legal counsel of my choice, and I represent and warrant that I have either sought legal counsel before signing this Release or have knowingly waived my right to do so.**
